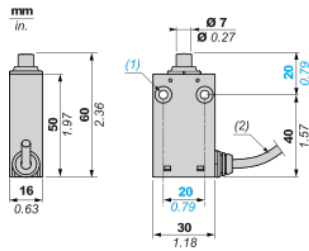

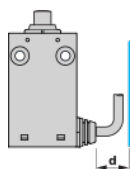

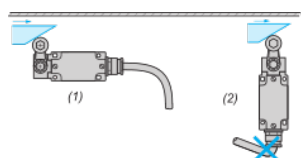

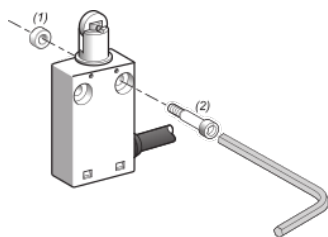
### Sweep of Connecting Cable

(1) : 2 spacers supplied with the switch

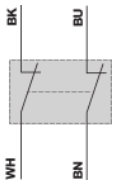

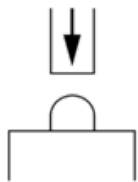
2-pole NC + NC snap action



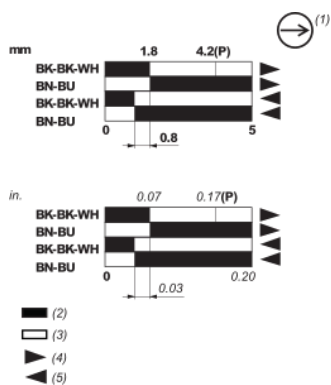
(BK) Black
